

The purpose of this guide is to provide BPA customers with a basic understanding of how to run reports on BEETS EEI and invoicing data. This guide assumes users have a basic understanding of BEETS and how it works. For general instruction around how to use BEETS, visit the <u>BEETS Landing Page</u> > <u>Training Materials & Support Resources</u> for additional resources, or contact the BPA Team for assistance.

#### TIPS:

- We recommend all new users of BEETS Reports Portal scan through the document and table of contents to **orient themselves on the content covered**.
- Utilize 'Ctrl F' to search for topics or terms you may be seeking guidance around.
- Click on Hyperlinks throughout the document to take you to other relevant information.
- Click on 'Return to Table of Contents' button at the bottom of each page to help navigate.

Microsoft SQL Server Reporting Services (SSRS) is a product that provides a set of tools and services that create, deploy, and manage reports. The **BEETS Reports Portal** is built on the SSRS platform and allows users to run on demand custom reports on EEI reporting data. These reports are <u>updated nightly</u> and can be exported to view and manipulate offline in a more manageable format. Proceed to the next pages for instructions on how to log in and run these reports.

#### The following reports are available on demand to BPA utility customers:

- <u>Activity Report</u> Report of all BEETS activity by utility, program and date
- <u>Utility Grouper Reports</u> Summary reports of utility bulk upload data (as well as associated payments and savings data) for UES and Custom Projects Option 2 programs.

*Throughout this guide, BEETS Reports Portal will be referred to as 'SSRS'.* 



# **Getting Started**

## Logging in to the BEETS Reports Portal





## Logging in to the BEETS Reports Portal (SSRS) (1 of 2)



Complete the following steps to log into the BEETS Reports Portal, which lives within a Microsoft SQL Server Reporting Services (SSRS) page. This site will allow you to run reports on demand around your BEETS activity.

#### Summary of Steps:

- 1. Go to SSRS by clicking on this <u>link</u>. We
- Input your BEETS Username and Password, and click the Sign In button.

**NOTE:** We HIGHLY recommend that users use **Google Chrome** browser to access SSRS; we have found that Microsoft Edge users have varied login experiences that may lead to issues accessing the BEETS Reports Portal.

- 3. If successful, you will be taken to the SQL Server Reporting Services (SSRS) Home Page.
- If you are <u>not</u> taken to the home page, you may need to sync your BEETS password with SSRS, follow the instructions to <u>sync your</u> <u>BEETS and SSRS passwords</u>.
- 5. Click on the *BPA* folder. 🔘

Summary of Steps, continued:

6. Click on the Utility Reports folder that appears.
(NOTE: May take a minute)



Pepending on permissions, some users may have additional folders in view.
Standard Reports are out of the box reports that may or may not be valuable for BPA customers, but have not yet been assessed for usefulness. Administration Reports are available to BPA team members only.

- 7. You will see two report types (and up to three reports); continue to the next page or click on links below for instructions on how to run these reports:

  - b) <u>BEETS Utility Grouper Reports</u> Summary reports of utility bulk upload data (as well as associated payments and savings data) for UES and Custom Projects Option 2 programs (if applicable).





- Completion Date Range: filter by 'Completion From Date:' and 'Completion To Date:' or select Null if not relevant
- Utility: filter by Utility or Select All; you will only see utility data you have access to
- Utility Specific Program: N/A, choose (Select All)
- Sector: filter by Sector or (Select All)
- **General Program:** filter by *Program* or *(Select All)*
- **Status:** filter by BEETS workflow *Status* or *(Select All)*



1. After logging in to SSRS, select BPA folder A > Utility Reports folder B > BPA C2 Activity Report or BPA UES Utility Grouper Report () (based on applicable bulk upload program).




#### **Syncing your BEETS and SSRS Passwords –** MAY BE REQUIRED THE FIRST TIME YOU LOG IN

If SSRS was not set up the first time you log into BEETS, you may need to perform the one-time task of syncing your passwords between BEETS and SSRS by resetting your BEETS password. From that point on, you will use the same username and password for both systems.


