BEETS Overview



Why BEETS?

BPA's current EE Reporting solution, IS 2.0, must be retired as the technology is no longer supported. Additionally, IS 2.0 lacks data visibility for customers, has limited workflow capability, and requires a significant amount of cross-system integrations that are challenging to manage.



BEETS, the new replacement system, will be released in fall 2022 and will improve BPA's energy-efficiency invoicing and reporting processes by providing:

- Automated workflows and data verification checks to help expedite processing
- Self-service, on demand reporting for customers
- Visual dashboards with visibility into application progress, budget and payments
- Ability to invoice at utility's convenience
- Centralized data across application submittal, invoicing, and performance payments



Integrated system allowing visibility into the process from submittal through payment.

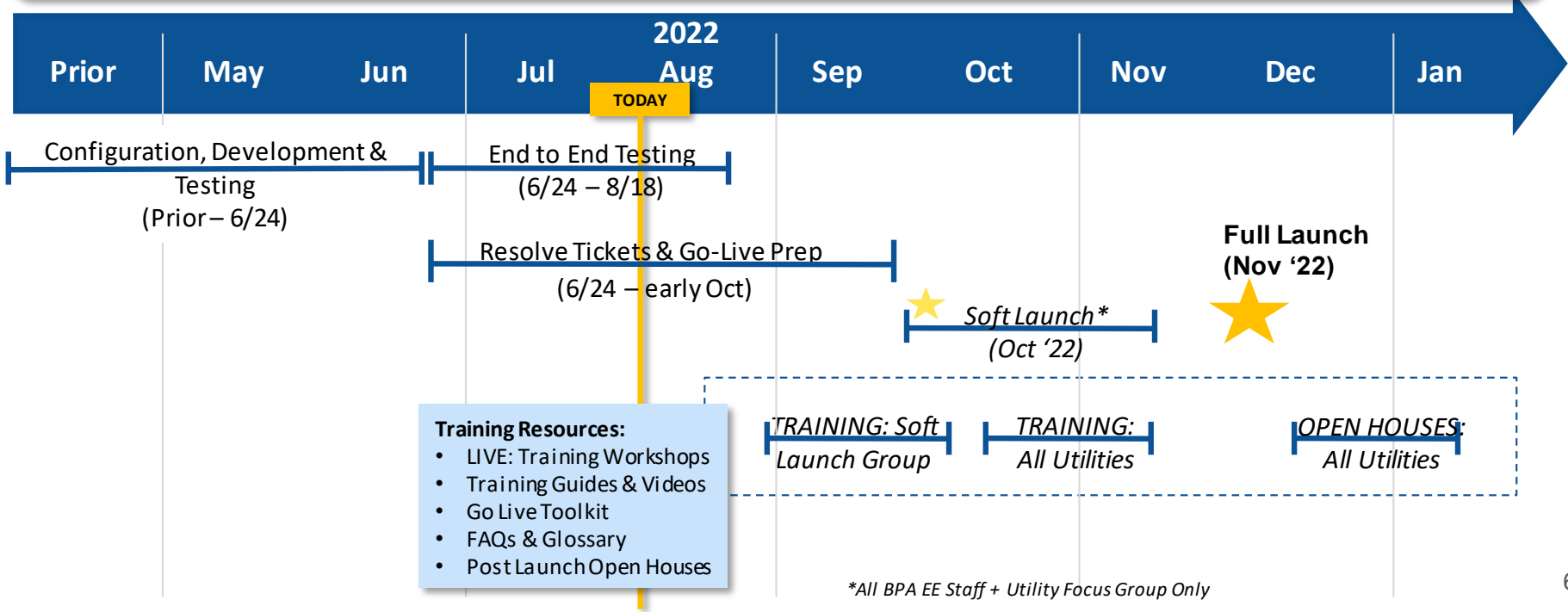

Currently in Week 5 end-to-end testing, with the Utility Focus Group joining next week. Dashboard development and financial integration work continues, but no show stoppers. **On Track to have all utilities transitioned to BEETS by end of CY'22!**

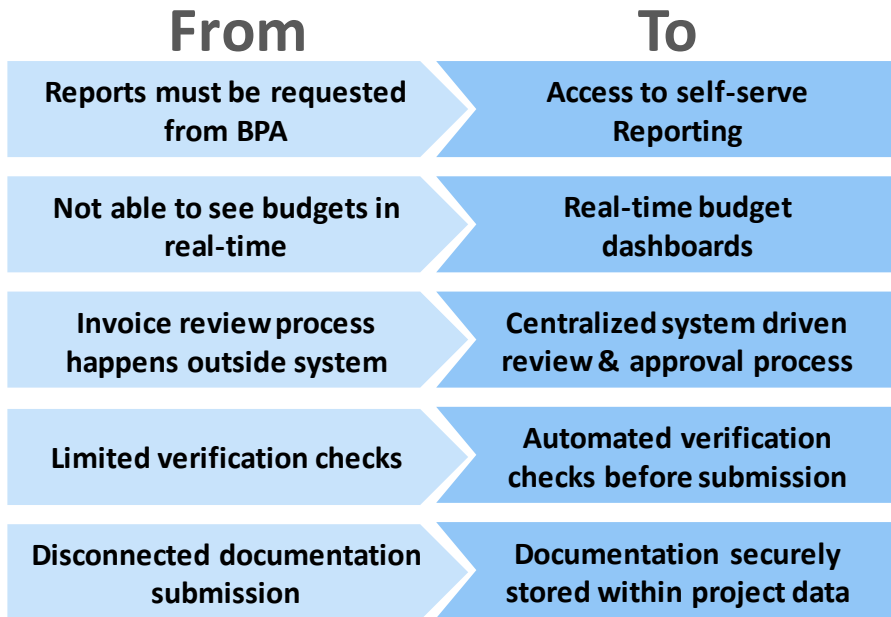
What's Changing?



Key Improvements



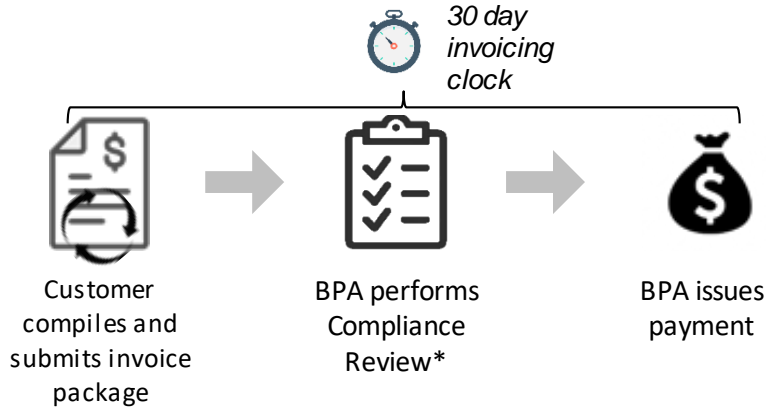
Multiple systems comprise an energy efficiency software solution that **lacks visibility, automated workflow, and cross-system integration.**



Single system to submit, manage, and track our energy efficiency process, from submission to invoicing.

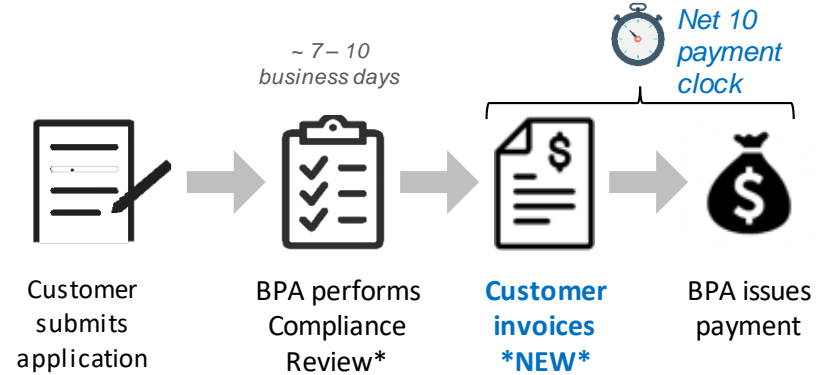
What's Changing? – EE Reporting Process

Current



Customers always get paid at 30 days

Future



Customers could get paid in LESS than 30 days

**Oversight performed if applicable*

What's Changing? – Performance Payments

Current

Automatic, but not flexible:

- Automatic Payment or Opt Out
- One bucket of funding
- Same Invoice for EEI and Performance Payments



Future

More steps, but more flexible:

- Customers control if, when and how much is paid
- Separate EEI & Performance Payment buckets
- Separate invoices for EEI and Performance Payments

What's Changing? – Implementation Manual

Specific Changes

- **Introduction (1):** Minor changes to improve clarity
- **Funding (2):** Rollover = Carryover; Bilateral transfer = Implementation budget transfer; BEETS updates; new allowance for partial self-funding
- **General Requirements (3):** Updated to reflect BEETS invoicing and reporting requirements
- **Custom Projects (4):** Updated to reflect reporting requirements in BEETS; small correction to calculation for incremental new construction costs; changes to Option 2 Custom Projects cost effectiveness requirements

Overall Changes

- Interim reporting requirements pages will be removed throughout the IM
- Many forms going away in favor of limited data collection in BEETS
- Minor corrections/clarifications
- HVAC Updates – DOE labeling

BEETS Glossary

- **Application:** Reported measure/project
- **Equipment** = Measure
- **Invoice:** Request for reimbursement (and/or documentation of self-funding); now a separate invoicing step in BEETS
- **Program:** Types of reported measures/projects that share common reporting requirements, calculations, and business rules (i.e. group of UES related measures now encompass the UES program)
- **Workflow:** Sequence of tasks included in the application process from submittal to invoicing where data is passed between users and/or systems.
