Mr. Bernton:

This communication is the Bonneville Power Administration's (BPA) final response to your request for agency records made under the Freedom of Information Act, 5 U.S.C. § 552 (FOIA). Your request was received on March 13, 2019, with a formal acknowledgement letter sent to you on March 22, 2019.

Request

"Any memorandums, or emails written by Kieran Connolly, BPA vice president of generation asset management, between June 1, 2018 and March 10, 2019 that contain the words 'power costs,' 'competition,' and 'solar' or 'wind' or 'natural gas.""

Response

BPA conducted a search of the electronic record files in the Generation Asset Management office. Responsive records comprised of 12 pages were located. BPA is herein releasing those 12 pages, with minor redactions applied under Exemption 6. An explanation of the statutory exemptions relied upon for those redactions follows.

The FOIA generally requires the release of all government records upon request. However, the FOIA permits withholding certain limited information that falls under one or more of nine statutory exemptions (5 U.S.C. §§ 552(b)(1-9)).

Exemption 6

The privacy exemption, 5 U.S.C. § 552(b)(6)(Exemption 6), protects information in "personnel and medical files and similar files" when the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy", if there is no public interest that outweighs the privacy interest. Here, BPA invokes Exemption 6 to protect personal cell phone numbers. BPA can find no public interest in releasing this information as it does not shed light on the mission or working of the agency.

Fees

There are no fees associated with the fulfillment of your request.

Certification

Pursuant to 10 C.F.R. § 1004.7(b)(2), I am the individual responsible for the records release and exemption determinations described above. Your FOIA request BPA-2019-00595-F is now closed with all available agency records provided.

Appeal

The adequacy of the search may be appealed within 90 calendar days from your receipt of this letter pursuant to 10 C.F.R. § 1004.8. Appeals should be addressed to:

The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. You may also submit your appeal by e-mail to OHA.filings@hq.doe.gov, including the phrase "Freedom of Information Appeal" in the subject line. (The Office of Hearings and Appeals prefers to receive appeals by email.) The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either (1) in the district where you reside, (2) where you have your principal place of business, (3) where DOE's records are situated, or (4) in the District of Columbia.
