Dear Mr. Hannah,

This communication concerns your agency records request submitted to the Bonneville Power Administration (BPA), made via the Freedom of Information Act, 5 U.S.C. § 552 (FOIA). Your request was received on April 14, 2021, and formally acknowledged on April 20, 2021.

#### Request

"Annual compensation (including base pay, commissions, overtime, bonuses, profit sharing, merit pay, incentives, housing allowance, retirement benefits, severance payments, etc.) for the Administrator and CEO, Deputy Administrator, Chief Operating Officer/ Acting Chief Operating Officer, Chief Administrative Officer, Senior Vice President - Power Services, Senior Vice President - Transmission Services, Executive Vice President – Chief Financial Officer, Executive Vice President - Chief Information Officer, Executive Vice President of Compliance, Audit, Risk Management, and EEO, Executive Vice President of Environment, Fish, and Wildlife, and Executive Vice President - General Counsel at Bonneville Power Administration for the calendar years of 2015, 2016, 2017, 2018, 2019, and 2020."

#### Response

BPA searched for and gathered responsive records from knowledgeable personnel in the agency's Payroll and Travel office. No records were found for several categories mentioned in your request, including commissions, profit sharing, merit pay, incentives, housing allowance, and severance payments. This is typical for government service. Retirement benefits in the federal government consist of Social Security benefits, Thrift Savings Plan investments, and the Federal Employee Retirement System Basic Benefits Plan. Records on individual retirement accounts are not held by BPA. Please note the Equal Employment Opportunity (EEO) Manager was included in the responsive records along with the Executive Vice President of Compliance, Audit and Risk Management who oversees Civil Rights & EEO.

Six pages of responsive records were located. Those six pages accompany this communication, with minor redactions applied under 5 U.S.C. § 552(b)(6) (Exemption 6). A more detailed explanation of the applied exemptions follows.

## **Explanation of Exemptions**

The FOIA generally requires the release of all agency records upon request. However, the FOIA permits or requires withholding certain limited information that falls under one or more of nine statutory exemptions (5 U.S.C. §§ 552(b)(1-9)). Further, section (b) of the FOIA, which contains the FOIA's nine statutory exemptions, also directs agencies to publicly release any reasonably segregable, non-exempt information that is contained in those records.

### Exemption 6

Exemption 6 serves to protect Personally Identifiable Information (PII) contained in agency records when no overriding public interest in the information exists. BPA does not find an overriding public interest in a release of the information redacted under Exemption 6— specifically, BPA employees' personal identification numbers. This information sheds no light on the executive functions of the agency, and BPA finds no overriding public interest in its release. BPA cannot waive these PII redactions, as the protections afforded by Exemption 6 belong to individuals and not to the agency.

Lastly, as required by 5 U.S.C. § 552(a)(8)(A), information has been withheld only in instances where (1) disclosure is prohibited by statute, or (2) BPA foresees that disclosure would harm an interest protected by the exemption cited for the record. When full disclosure of a record is not possible, the FOIA statute further requires that BPA take reasonable steps to segregate and release nonexempt information. The agency has determined that in certain instances partial disclosure is possible, and has accordingly segregated the records into exempt and non-exempt portions.

### Fees

There are no fees associated with processing your FOIA request.

### Certification

Pursuant to 10 C.F.R. § 1004.7(b)(2), I am the individual responsible for the records search and information release and exemption determinations described above. Your FOIA request BPA-2021-00584-F is now closed with the responsive agency information provided.

## Appeal

The adequacy of the search may be appealed within 90 calendar days from your receipt of this letter pursuant to 10 C.F.R. § 1004.8. Appeals should be addressed to:

(The Office of Hearings and Appeals prefers to receive appeals by email.) The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either (1) in the district where you reside, (2) where you have your principal place of business, (3) where DOE's records are situated, or (4) in the District of Columbia.
