COVID-19 Information: Notice For In-Person Meetings

The Public Health Emergency for COVID-19, declared under Section 319 of the Public Health Service Act expired on May 11, 2023, but COVID-19 safety protocols are still in place. Everyone entering BPA facilities, worksites or areas where BPA work is being conducted is required to take a [self-screen questionnaire](#) prior to entry.

In addition, visitors will be required to wear a mask when the county [COVID-19 Community Level](#) impact is HIGH (RED). Masks are optional for all visitors when the county COVID-19 Community Level impact is LOW (GREEN) or MEDIUM (YELLOW). Visitors may be asked to momentarily lower masks to confirm identity when going through security points. This policy will remain in effect until further notice.

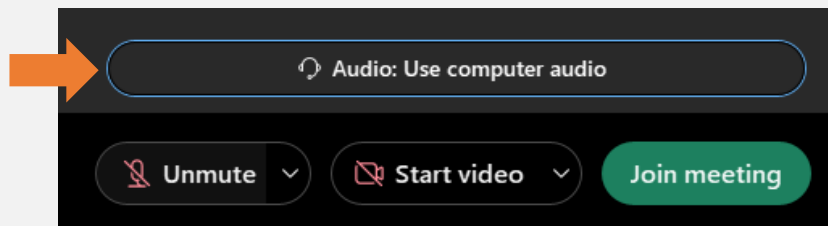

Rates Hearing Room Webex Instructions

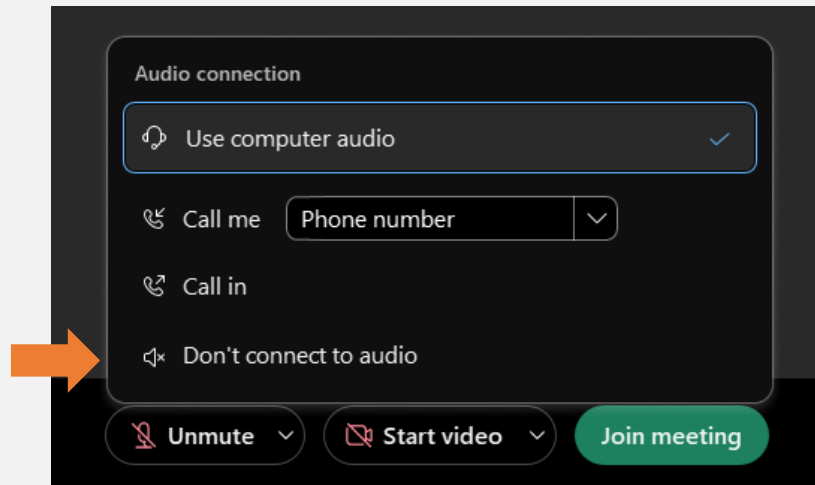
You are welcome to connect to the meeting Webex while in the Rates Hearing Room. However, your Webex audio must be fully disconnected (not just on mute).

As you join the meeting, there is an option to adjust your audio settings in the control panel at the bottom of your screen:

1. Click the “Audio: Use computer audio” button



2. From the pop up menu, select “Don't connect to audio”



If you have already joined the Webex with audio connected:

1. In the Webex control panel for audio, click “Switch Audio”
2. Select “Disconnect”
3. You will know you are successful when your control panel shows a button to “Connect audio”.
