

Generator Interconnection Reform (GQR)

Landscape

- Nationwide exponential increase in Generator Interconnection (GI) queues
- Resulting in large backlog in study process
 - Current process cannot accommodate the large amounts of requests in the queue in a timely manner
- Creating obstacles for new resources to get

Possible Solution


- Implement a first-ready, first-served cluster study process in order to:
 - Increase the speed of interconnection queue processing
 - Address queue backlogs and study delays
- BPA is reviewing and considering FERC approved reforms made by other transmission providers
- Pursuing reforms in a TC-25 proceeding
 - The FERC NOPR is not intended to divert or slow the potential progress of transmission providers






TC-25 Timeline, Expectations and Principles

Approach to Customer Engagement

Most identified issues will be presented according to the following process at workshops (multiple steps might be addressed in a single workshop):



• Teams will follow the steps that may be covered in one workshop or more based on the complexity of the issue.

Customer Led Workshops

- Within one week after every workshop, customers can request a Customer Led workshop that would focus on topics presented in the previous workshop.
- The identified Customer Led workshops are April 11 and May 11.
- Customers should provide the topic and estimated time needed for discussion with BPA SMEs.
- BPA will not create new content this is an opportunity to ask further questions on materials previously presented.
- Opportunities for customers to present on topics of interest, where BPA will be in listening and understanding mode.


Expectations

- Customers will have an opportunity to provide comments after every workshop
- BPA will post customer comments on the TC-25
 Tariff Proceeding website
- All comments received will be reviewed, summarized and addressed in June 2023
- Workshops presented by BPA in April and May 2023 will be hybrid
- All other workshops will be virtual

TC-25 Tariff Principles

- Maintain a tariff that is consistent with the FERC pro forma tariff to the extent possible.
- BPA will consider differences from the FERC pro forma tariff if the difference is necessary to:
 - Implement BPA's statutory and legal obligations, authorities, or responsibilities;
 - Maintain the reliable and efficient operation of the federal system;
 - Prevent significant harm or provide significant benefit to BPA's mission or the region, including BPA's customers and stakeholders; or
 - Align with industry best practice when the FERC pro forma tariff is lagging behind industry best practice, including instances of BPA setting the industry best practice.
