Dear Mr. Schick,

This communication is the Bonneville Power Administration (BPA) formal response to your FOIA request BPA-2024-02013-F. The agency received your request for records made under the Freedom of Information Act, 5 U.S.C. § 552 (FOIA) on May 31, 2024, BPA formally acknowledged your request vis letter and email on June 26, 2024.

### Request

You seek, "...any risk, revenue, or overall financial analyses [dated] since 2017, [which analyses] model growth in wind and solar generation and/or major transmission capacity increases."

### Response

Knowledgeable Public Utilities Specialist Subject Matter Experts (SMEs) in the agency's Power Services organization have assembled the following information to share with you in response to your FOIA request.

Knowledgeable SMEs report that all Power Services mid-to-long range fundamental price forecasts include modeling growth of wind and solar—with more limited changes on the transmission capacity side—suggesting that all risk, revenue, and financial analyses done using those price forecasts could be responsive to your request. That said, our Power Services SMEs assembled the most responsive information you seek. That information follows.

The most recent BPA (Power Services) analysis of growth in wind and solar generation is for the 2024 Resource Program. Materials for that study, as well as all prior Resource Programs, are publicly available at:

The 2024 Resource Program includes both a Base ('RP2024') and Fast Transition scenario ('RP2024\_FT'). The Fast Transition scenario represents future build-out needs to achieve net zero emissions by 2050, and thus has a larger and earlier renewable resource build out. The Fast Transition scenario, called the "High Policy" scenario for the 2022 Resource Program, represents a 'plausibly high' case, not intended to be a rigorous study of how or if the WECC achieves zero/net zero emissions, or how quickly it could do so.

Note that BPA Power does not model any scenarios without wind and solar growth.

The BP-24 Rate Proceeding Final Proposal Power Market Price Study from July 2023, *Section 2.3.7 Generation Additions and Retirements* on page 20, describes BPA's methodology used for the BP-24 Rate Case to evaluate additions and retirements:

The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. You may also submit your appeal by e-mail to OHA.filings@hq.doe.gov, including the phrase "Freedom of Information Appeal" in the subject line. (The Office of Hearings and Appeals prefers to receive appeals by email.) The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either (1) in the district where you reside, (2) where you have your principal place of business, (3) where DOE's records are situated, or (4) in the District of Columbia.
