This communication is the Bonneville Power Administration's (BPA) final response to your request for agency records made under the Freedom of Information Act, 5 U.S.C. § 552 (FOIA). BPA received your records request on June 12, 2024, and formally acknowledged your request on July 12, 2024.

(The Office of Hearings and Appeals prefers to receive appeals by email.) The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either (1) in the district where you reside, (2) where you have your principal place of business, (3) where DOE's records are situated, or (4) in the District of Columbia.

Hi Debby and Dallas,

I was talking to Eric at Idaho Power yesterday and he noted that they're planning a "dam raise" at Anderson Ranch. I don't think this project will change the MVA capability of the project, but it may change how they operate – if you haven't already been talking with USBR about this, I wanted to let you know it might be good to find out what it may change from our perspective. The bank is undersized today, so if they increase their output before the replacement we might have additional loss of life.
